
The meeting will be held on Thursday, October 20, 2022 at 11:30 a.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

- 1. Public Comments;
- 2. Review and approve the minutes of the September 15, 2022, Board meeting;
- 3. Conduct a public hearing regarding the adoption of the District's 2022 tax rate;
- 4. Levy of the District's 2022 tax rate, and the adoption of an Order in connection therewith;
- 5. Approval and execution of an Amendment to the District's District Information Form in connection with the levy of the District's 2022 tax rate;
- 6. Bookkeeper's report, including financial and investment reports, and the taking of any actions required in connection therewith, including authorizing the payment of invoices presented;
- 7. Status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting and authorize any action in connection therewith;
- 8. Annual review of Order Establishing Policy for Investment of District Funds and Appointing Investment Officer, and adoption of Resolution and amended Order in connection therewith;
