NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas, said address being an office and meeting place of the District.

The meeting will be held on Thursday, October 19, 2023 at 11:30 a.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Public Comments;
2. Review and approve the minutes of the September 29, 2023, Board meeting;
3. Conduct a public hearing regarding the adoption of the District's proposed 2023 tax rate;
4. Levy of the District's 2023 taxes, and the adoption of an Order in connection therewith;
5. Approval and execution of an Amendment to the Second Amended and Restated District Information Form regarding the 2023 tax rate;
6. Bookkeeper's report, including financial and investment reports, and the taking of any actions required in connection therewith, including authorizing the payment of invoices presented;
7. Annual review of Order Establishing Policy for Investment of District Funds and Appointing Investment Officer, and adoption of Resolution and amended Order in connection therewith;
8. Status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting and authorize any action in connection therewith;
9. Tax Assessor-Collector's Report, including status of delinquent taxes; authorize the payment of invoices presented, approval of tax refunds, and transfer of accounts to the uncollectible roll;
10. Report any legal action taken by the District's delinquent tax collections attorney; take any action in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
11. Engineer's report, including:
 - A. Authorizing the design, advertisement for bids and/or award of construction contracts or concurrence in the award of a contract for the construction of water, sanitary sewer and drainage facilities within the District, and authorize acceptance of Texas Ethics Commission Form 1295 ("TEC Form 1295");
 - B. Status of construction contracts, including the approval of any change orders and/or acceptance of facilities for operation and maintenance purposes, and authorize acceptance of TEC Form 1295, as applicable; and

- C. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and authorize acceptance of TEC Form 1295, as applicable; and the taking of any action in connection therewith;
12. Operator's Report, including:
 - A. Levels of chlorine residuals;
 - B. Authorize repair and maintenance of District facilities, and authorize acceptance of TEC form 1295, as applicable;
 - C. Appeal(s) of District charges;
 - D. Refer accounts for collection;
 - E. Approve write-off of uncollectible accounts; and
 - F. Water accountability; and
 - G. Consider amendment of the District's Rate Order;
 13. Developer's Report;
 14. Closed session for consultation with attorney regarding pending and/or threatened litigation;
 15. Reconvene in open session and authorize action on matters discussed in closed session;
 16. Attorney's Report;
 17. Consider matters for possible placement on future agendas.
