 - i. sanitary sewer system cleaning and televising program, area III.
 - e. service requests and repairs of District facilities;
 - f. North Harris County Regional Water Authority matters including approve Interlocal Cost Sharing Agreement;
 - g. permitting, maintenance, and operation of storm water drainage facilities in Hidden Falls;
 - h. capital improvement plan and project status summary;
 - i. emergency interconnect with Malcomson Road Utility District; and
 - j. consent to encroachment.
