NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above-captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Texas 77056, said address being a meeting place of the District.

The meeting will be held on Monday, November 13, 2023, at 11:00 a.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Receive public comments, including comments and requests submitted through the District's website, and matters of public interest;
2. Review and approval of the minutes of the meetings of the Board of Directors held on October 5, 2023, and October 9, 2023;
3. Bookkeeper's report, including (i) financial and investment reports and the payment of invoices presented, and (ii) status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting and authorize any action in connection therewith;
4. Receive Tax Assessor-Collector report and approve payment of invoices presented and moving of accounts to uncollectible roll;
5. Report on legal action taken by the District's delinquent tax collections attorney, authorize foreclosure proceedings, installment agreements, and the filing of proofs of claim;
6. Operator's Report, including:
 - a) Monthly report;
 - b) Status of drought conditions and implementation of drought contingency plan;
 - c) Repair and maintenance of District facilities;
 - d) Appeals of District charges and consideration of customer comments;
 - e) Status of installation of smart meters and status of communication with residents regarding same;
 - f) Water Smart Partners Program discussion and authorize action in connection therewith, including status of participation in community programs;
 - g) Status of high water usage program and issuance of notices regarding same;
 - h) Discuss status of Air Scouring Program;
 - i) Discussion regarding automated payment reminders to customers, and authorize action in connection therewith; and
 - j) Request for renewal of Letter Agreement for Temporary Fuel Surcharge between the District and Inframark, LLC;

7. Engineer's Report, including:
 - a) Authorizing the design and/or advertisement for bids for the construction of facilities within the District;
 - b) Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District;
 - c) Status of construction of water, sewer and drainage facilities and paving to serve land within the District, including the approval of any pay estimates and/or change orders, and acceptance by Harris County of streets for maintenance;
 - d) Authorizing the design, advertisement, or award of construction contracts or concurrence in the award of contracts for the construction of recreational facilities within the District;
 - e) Status of construction of recreational facilities to serve land within the District, and the approval of any change orders;
 - f) Discussion regarding status of general landscaping improvements within the District, including review of proposals for maintenance of District facilities;
 - g) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, acceptance of facilities for operation and maintenance purposes, and conveyance of sites and/or facilities by the District;
 - h) Status of storm water permitting related to construction within the District, and the taking of action in connection therewith;
 - i) Status of acceptance by Harris County of streets and storm sewers for maintenance;
 - j) Discussion regarding Capital Improvements Plan, and authorize any action necessary in connection therewith; and
 - k) Review of quotes for bridge railing repairs and authorize any action necessary in connection therewith;

Consider projects available for funding with surplus bond proceeds and, if necessary, adoption of an Order Authorizing Application to the Texas Commission on Environmental Quality for Approval of Projects and the Use of Surplus Construction Funds and Interest Earned on Construction Funds in connection therewith;
9. Garbage Collection and Recycling Report from Republic Services, Inc.;
10. Status of law enforcement services within the District; discuss status of safety committee and coordination with Harris County Constable, Precinct 5 ("Precinct 5") and Bridgeland Council, Inc. regarding patrols within Bridgeland;
11. Matters related to the Bridgeland Water Agency ("Agency") and directives to the District's Trustee and Alternate(s), and report on results of meeting of the Agency;
12. Updates and revisions to District website;
13. Developer's report;
14. Matters relative to Bridgeland Council, Inc.;

15. Discussion of matters relative to Lakeland Village Homeowners' Association ("HOA") and authorize any action necessary in connection therewith, including:
 - a) Review and consider the contribution of District funds towards the proposed construction by the HOA of the following:
 - i. Repair of section of walking trail located at House Hahl Trail near Parkside Haven Dr.;
 - ii. Remodel of Bridgeland Central Park Fountain; and
 - iii. Landscaping enhancements to serve various sections of the Bridgeland community;
16. Authorize attorney to file Eminent Domain Report with the Texas Comptroller of Public Accounts prior to February 1, 2024, pursuant to § 2206.154, Texas Government Code;
17. Receive and act upon Municipal Securities Rulemaking Board Rule G-10 letter from Masterson Advisors LLC;
18. Attorney's Report;
19. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, for consultation with the District's attorney regarding the acquisition of real property;
20. Reconvene in Open Session and take action regarding the acquisition of real property, including review and approval of appraisal of property, and authorize preparation of offer letters;
21. Matters related to the Directors Election to be called for May 4, 2024, including authorization to post Notice Regarding Candidate Filing Period;
22. Schedule of future Board meetings; and
23. Matters for possible placement on future agendas.
