NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a public meeting at 1300 Post Oak Boulevard, Suite 2500, Houston, Harris County, Texas, said address being a meeting place of the District.

The meeting will be held on Thursday, March 7, 2024, at 12:00 p.m.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Public comments;
2. Approval of the minutes of the January 4, 2024 and February 1, 2024, Board of Directors meetings;
3. Bookkeeper's Report, including financial and investment reports, and authorizing the payment of invoices presented;
4. Authorize consultants to research unclaimed property and consider authorizing bookkeeper to prepare Unclaimed Property Report as of March 1, 2024;
5. Tax Assessor-Collector Report, including authorizing the payment of invoices presented and the approval of moving accounts to the uncollectible roll;
6. Sales Revenue, Inc. Report;
7. Report and legal action taken by the District's delinquent tax collection attorney, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
8. Operations Report, including:
 - (a) Authorize the repair and maintenance of District facilities;
 - (b) Appeals of District charges;
 - (c) Refer accounts for collection;
 - (d) Approve write-off of uncollectible accounts;
 - (e) Status of installation of outflow pipe and sump pump within the building at the Water Plant in connection with the generator at the Water Plant;
 - (f) Status of receipt of water from Harris County Municipal Utility District No. 216 ("MUD 216"), in connection with MUD 216 paying back the District in kind for its prior use of the shared interconnect;
 - (g) Status of communications with certain fiber optic subcontractors regarding reimbursement for the costs of repairs to District water lines; and
 - (h) Authorize annual submission to each electric utility that provides transmission and distribution service to the District and each retail electric provider for determination

of District facilities that qualify for critical load status relative to compliance with §13.1396, Texas Water Code;

9. Authorize review of Water Conservation Plan and status of review of the District's Drought Contingency Plan;
10. Engineer's Report, including:
 - (a) Authorizing the design, advertisement for bids and/or award of construction contracts or concurrence in the award of a contract, and authorize acceptance of Texas Ethics Commission ("TEC") Form 1295;
 - (b) Status of construction contracts, including the approval of any change orders, authorize acceptance of TEC Form 1295, and/or acceptance of facilities for operation and maintenance purposes;
 - (c) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District;
 - (d) Review and approval of Storm Water Quality Management Plans related to construction contracts;
 - (e) Status of Harris County Municipal Utility District No. 345's purchase of generator at Wastewater Treatment Plant; and
 - (f) Discussion regarding District's Capital Improvement Plan;
11. Status of the Lead Houeline Survey for the Lead and Copper Regulation compliance and authorize any action in connection therewith;
12. Issuance of utility commitments;
13. Status of construction of the Barker-Cypress sidewalk project by Harris County Municipal Utility District No. 346;
14. Storm Water Solutions, LLC Report;
15. Attorney's Report;
16. Consideration of matters for possible placement on future agendas.
