

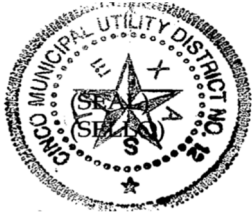
## NOTICE OF MEETING


### CINCO MUNICIPAL UTILITY DISTRICT NO. 12

The Board of Directors of Cinco Municipal Utility District No. 12 will hold a regular meeting on **Monday, April 10, 2023, at 6:00 p.m.**, at the Cinco Ranch Residential Property Association, 3022 Windemere Park Lane, Katy, Texas, to discuss and, if appropriate, act upon the following items:

1. Pledge of Allegiance.
2. Comments from the public.
3. Approve minutes.
4. Website matters.
5. Update on Central Green events, including Christmas Broadcast and concert production proposal.
6. Tax assessment and collections matters, including delinquent tax collections, installment agreements, payment of tax bills, writing off uncollectible personal property accounts, and report regarding sales tax revenues, if appropriate.
7. Sales tax review report.
8. Financial and bookkeeping matters, including payment of the bills, review of investments, previously issued check matters, and amendment of budget, if appropriate.
9. Engineering matters, including:
  - a. Phase II MS4 permitting matters;
  - b. requests for consents to encroachment, utility commitment letters or reservations of capacity from Cinco Municipal Utility District No. 1; and
  - c. pedestrian signs and traffic light coordination near Cinco Ranch High School.
10. Operation of District facilities, including:
  - a. billings, repairs and maintenance, and water bill messages;
  - b. update on smart meter installation;
  - c. conduct annual review and receive report from operator on Identity Theft Prevention Program; and
  - d. approve annual report on implementation of Water Conservation Plan.
11. Termination of water and sewer service to delinquent customers and authorize termination of service.
12. Update on LMA Landscape improvements, including:
  - a. park enhancements;
  - b. tree removal and vegetation replacement throughout the District; and
  - c. sidewalk repairs near lake.

13. Discuss security reports, deputy matters, law enforcement equipment, and authorize appropriate action.
14. Discuss garbage matters and authorize appropriate action.
15. Community improvements, including contribution for pickleball courts, potential location for same, and authorize appropriate action.
16. Discuss noise walls.
17. Corps of Engineer's upstream litigation and related litigation.
18. Meeting schedule, including scheduling special meeting, if appropriate, and items for inclusion on the next agenda.
