The Board of Directors of Cinco Municipal Utility District No. 14 will hold a regular meeting on Wednesday, March 27, 2024, at 11:00 a.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Sabine Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Receive public comments.
2. Approve minutes.
3. Garbage and recycling matters.
4. Financial and bookkeeping matters, including:
 - a. payment of bills and review of investments; and
 - b. discuss community donation requests and authorize appropriate action.
5. Tax assessment and collection matters, including delinquent tax collections, installment agreements, and payment of tax bills.
6. Engineering matters, including approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company of completed projects.
7. Review Critical Load Spreadsheet for District's facilities and authorize annual filing.
8. Review Emergency Preparedness Plan and authorize filing of updates, if necessary.
9. Storm water permitting matters and Storm Water Management Program.
10. Operation of District facilities, including:
 - a. billings, repairs and maintenance;
 - b. repairs and maintenance of water and sewer system per 5-year plan, including report on valve survey;
 - c. smart meter matters;
 - d. conduct annual review and receive report from operator on Identity Theft Prevention Program and adopt Identity Theft Prevention Program Amendment;
 - e. review Drought Contingency Plan and adopt Order Adopting Amended and Restated Drought Contingency Plan;
 - f. amend Rate Order, as necessary; and
 - g. hearing on termination of water and sewer service to delinquent customers.
11. Review Water Conservation Plan, including:
 - a. approve annual report and 5-year water conservation implementation report on implementation of Water Conservation Plan;
