The Board of Directors of Cinco Municipal Utility District No. 14 will hold a regular meeting on Wednesday, May 24, 2023, at 11:00 a.m., at the offices of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2400, Sabine Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Receive public comments.
2. Approve minutes.
3. Garbage and recycling matters.
4. Financial and bookkeeping matters, including:
 - a. payment of bills and review of investments; and
 - b. discuss community donation requests and authorize appropriate action.
5. Travel Reimbursement Guidelines and Director Expenses for the Association of Water Board Directors summer conference.
6. Tax assessment and collection matters, including delinquent tax collections, installment agreements, and payment of tax bills.
7. Engineering matters, including approve pay estimates and change orders, authorize final acceptance of projects, and direct engineer to notify insurance company of completed projects.
8. Review Emergency Preparedness Plan and authorize filing of updates, if necessary.
9. Storm water permitting matters and Storm Water Management Program.
10. Operation of District facilities, including:
 - a. billings, repairs and maintenance;
 - b. repairs and maintenance of water and sewer system per 5-year plan, including report on valve survey;
 - c. smart meter matters;
 - d. amend Rate Order, as necessary;
 - e. approve Consumer Confidence Report and authorize operator to mail Consumer Confidence Report and file certificate of mailing with the Texas Commission on Environmental Quality; and
 - f. hearing on termination of water and sewer service to delinquent customers.
11. North Fort Bend Water Authority matters, including discuss Water Provider Conservation Program.
12. District website matters.
13. Discuss meeting schedule.
14. Reports from Directors and District Consultants on District operations.
