The meeting will be held on Tuesday, October 3, 2023, at 12:00 p.m.

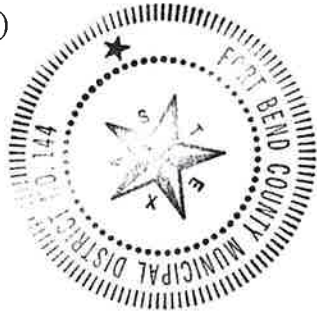
The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:

1. Receive public comments;
2. Approval of the minutes of the September 5, 2023, Board of Directors meeting;
3. Conduct a public hearing regarding the adoption of the District's 2023 tax rate;
4. Levy of the District's 2023 debt service and maintenance tax rates, and the adoption of an Order in connection therewith;
5. Approval and execution of an Amended District Information Form;
6. Tax Assessor-Collector's Report and authorize the payment of invoices presented moving of accounts to uncollectible roll;
7. Report on legal action taken by the District's delinquent tax collections attorney, and take any action in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
8. Bookkeeper's report, including financial and investment reports; authorize the payment of invoices presented;
9. Status of compliance by the District with Texas Government Code, Chapter 2265, relative to energy reporting;
10. Annual review of Order Establishing Policy for Investment of District Funds and Appointing Investment Officer, and adoption of Resolution and amended Order in connection therewith;
11. Engineer's report, including:
  - a) Authorizing the design and/or advertisement for bids for the construction of facilities within the District, including:
    - i. Detention and Drainage Facilities Rehabilitation Project Phases I and II;
  - b) Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District and related real property matters concerning the District;
  - c) Authorizing the award of construction contracts or concurrence of award of

- contracts for the construction of facilities within the District, and authorize acceptance of Texas Ethics Commission Form 1295;
- d) Status of ongoing construction of facilities to serve land within the District, including the approval of any change orders, and authorize acceptance of Texas Ethics Commission Form 1295;
  - e) Acceptance of facilities for ownership; and
  - f) General engineering matters, including status of compliance with Chapter 191, Texas Natural Resources Code ("Antiquities Code");
12. Matters pertaining to Rosenberg, including:
- a) Status of conveyance of water, sewer and drainage facilities to Rosenberg; and
  - b) Status of conveyance of sites and/or easements related to water, sewer and drainage facilities to Rosenberg;
13. Attorney's Report; and
14. Schedule for upcoming meetings and matters for possible placement on future agendas.
